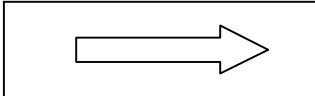

Tuition for the 2009-2010 School year will be \$5,525. \$500 of that is paid at the time of registration leaving a balance of \$5,025. If you received an STO award, that amount will need to be subtracted to give you a revised balance.

Our current tuition payment plan calls for 9 monthly payments (October thru June) which for 2009-2010 will be \$558.33 per payment (assuming no STO award). Knowing that most people operate on a monthly budget we wanted to break it down to the monthly payment and work from this number.
